Refer to the Lighting Incentive Catalog for measure requirements and information.

- Complete the table corresponding to the measure in the catalog.
- If the new equipment is listed under DesignLights Consortium™ (DLC) TRT V4.4, use the tested data for wattage of new equipment (green background). If the tested data is not available and only family data is available (yellow background), then use the wattage listed on the specification sheet of the new equipment.
- If the new equipment is listed under ENERGY STAR®, then use the wattage on the ENERGY STAR certification instead of the specification sheet.
- If applying for an interior or exterior LED sign light measure, please include the existing ballast make and model number in addition to the specific lamp type or provide metering data (amperage and voltage readings) of the existing equipment.
- Round both Existing Equipment and New Equipment Wattage to the nearest integer.
