

2020 HEATING AND COOLING INCENTIVE APPLICATION

As a customer of a utility that participates in Wisconsin's FOCUS ON ENERGY®, you may be eligible for incentives on heating and cooling equipment. Retain a copy of your application and supporting materials for your records.

Step 1: Check your eligibility

Your equipment must be purchased and installed in **2020. This application and incentives are effective January 1, 2020. Incentives are subject to change.**

You may qualify for even higher incentives

Focus on Energy offers standard incentives (Tier 1) regardless of income. However, if your household income is at or below the amounts in the table below, you may qualify for higher incentives (Tier 2).

Step 2: Complete your application

Please fill out all fields unless otherwise directed, and make sure to sign your application. Incomplete or missing information will delay processing.

What you'll need:

- A copy of your sales receipt/invoice indicating, model number, purchase/installation date and price.
- A copy of your AHRI Certificate (if required).
- A copy of your Tier 2 Approval Letter or your Income Eligibility Application (if eligible for Tier 2).

Step 3: Submit paperwork

Submit the application **within 60 days of the equipment installation** along with supporting documentation to Focus on Energy at the address below. Please allow up to **8–10 weeks** for processing and retain a copy for your records.
